Qualifying criteria for interested contractor/bidder:

1. Registered with Govt./Semi Govt. Departments/Autonomous Bodies .
2. Average Annual Turnover during for last 3 consecutive financial years shall not be less than **7.33 lakhs**.
3. Should have **completed** satisfactorily Civil works (Buildings) of (i) *one work* of value not less than **17.76 Lakh against single work order OR** (ii) two works of value not less than **11.10 Lakh** each against *two separate work orders OR* (iii) three works of value not less than **8.88 Lakh** each against *three separate work orders* during last seven years in Govt./ Semi Govt. Department/Autonomous Body supported by **work order and completion certificate.**
4. **Bidders who meet the minimum qualification criteria will be qualified only if their available bid capacity at the expected time of bidding is more than the total bid value. The assessed available bid capacity will have to be calculated and submitted by the bidder as per Annexure-V of the tender document.**
5. The tenderer shall sign and stamp each page of this tender document as a token of having read, understood and comply with tender, the terms and conditions contained herein. This tender document is required to be uploaded on the website <https://eprocure.gov.in> along with scanned copies PAN, GST and other qualifying documents, as per the qualifying criteria stated above in serial no.1,2 and 3. Incomplete bid/documents shall be rejected without giving any reason. **There is no need to submit the hard copy of the Tender and other documents except Original Bid Security Declaration & Declaration regarding correctness of information submitted in this Tender as per NIT in affidavit (As per Annexure VII) and Tender Fee (non-refundable).**

Bidders will be required upload the scanned copies of the Demand Draft against tender fee (non-refundable) drawn in favour of the Registrar, Tezpur University payable at Tezpur along with the Bid Security Declaration in affidavit and other qualifying documents as per tender and sealed and signed tender document.
7. **Original Bid Security Declaration & Declaration regarding correctness of information submitted in this Tender as per NIT in Affidavit and tender fee (non-refundable)** must be submitted in a sealed envelope to be super scribed this tender name & the name of your agency and must reach ***The Registrar, Tezpur University*** before the last date & time for receipt of Bid. ***Tender without the Bid Security Declaration and Tender Fee (Non-refundable) will be summarily rejected.***
8. **Bidder's Technical capability will be determined as per the format given in Annexure-VIII. Technically disqualified bidder's price bid will not be opened and will not be considered for the next step.**
9. Downloading of tender paper by a bidder does not automatically mean that the bidder is considered qualified for the work. Tezpur University reserves the right to accept or reject any or all the tender document without assigning any reason thereof .
10. The acceptance of tender will rest with the authority of Tezpur University, Napaam , Tezpur who does not bind itself to accept the lowest tender and reserves to itself the right to reject any or all the tenders received without assigning any reason thereof. The work may be allotted in part or whole at the discretion of competent authority of the University.
