Quotations are hereby invited in 02 Bid System (**Technical and Financial**) reputed manufacturers/dealers for supply of bedroll items **strictly on RENT BASIS only** as detailed below for Tezpur University.

Please read the Bid document carefully before participating. It shall be deemed that submission of bid by the bidder has been done after their careful study and examination of the Bid terms and conditions with full understanding to its implications. Any lack of information shall not in any way relieve the bidder of its responsibility to fulfill its obligations under the Bid.

The University will reject a proposal for award if it determines that the bidder recommended for award has engaged in corrupt or fraudulent practices in competing for, or in executing, the Purchase Order. Fraudulent Practice means a misrepresentation of facts in order to influence a procurement process and includes collusive practice among bidders (prior to or after Bid submission) designed to establish Bid prices at artificial non-competitive levels and to deprive Tezpur University of the benefits of free and fair competition. Corrupt Practice means offering, giving, receiving or soliciting of anything of value, pressurizing to influence the action of a public official in the process of this purchase execution.

A. GENERAL TERMS & CONDITIONS:

- i) **Rates:** Rates quoted should be on **FOR Tezpur University, Napam, Tezpur, Door Delivery Basis**, for indigenous items and **CIP Tezpur University, Napam, Tezpur or Delivered Duty Paid**, for imported item. Failure to comply with this term may lead to rejection of the quotation.
- ii) **Quotations should be accompanied by:**
 - (a) **An EMD (in the form of Demand Draft/Banker Cheque) for Rs. 3200/- (Rupees Three Thousand Two Hundred only drawn in favor of Registrar, Tezpur University, payable at Tezpur. No request for consideration of earlier deposited EMD will be considered.**
 - (b) **ii) Bidders who are MSME/NSIC registered needs to furnish a "Bid Security Declaration" (format enclosed at Annexure - II) in lieu of EMD accepting that if they withdraw or modify their bids during process of bidding, they will be suspended for a period of Three (03) years from participating in any future bid invited/published by Tezpur University. Bidders who are MSME/NSIC registered seeking exemption from payment of EMD are to submit valid documents in support of their claim. Bidders seeking exemption are asked to clearly mention the category under which exemption is claimed. The category of exemption under MSME/NSIC will be strictly adhered to.**
- iii) Bidders must note that both technical and financial quotes are to be placed in separate properly sealed envelopes and both the envelopes must be placed together in a separate envelope super scribing **"Quotations for Bedroll Supply for 21st Convocation, Tezpur University.**

- v) The successful bidder must note that the bedroll items as mentioned at Annexure I must be delivered at the doorstep of concerned hostels of Tezpur University. Rates are to be quoted accordingly.
- vi) The delivery has to be made in a staggered manner. The successful bidder has to supply 1000 sets (Set 1 items) of the items on Dec 30 and an additional 500 sets of items (Set 2 items) on Dec 31 are to be supplied on Day-2.
- vii) The successful bidder may note that rent shall be paid for two days for the Set 1 items supplied on Day 1 and rent for one day shall be paid for the Set 2 items supplied on Day-2.
- viii) The successful bidder must arrange for collection of all the supplied items after end of the programme from the University hostels at his/her own cost.
- ix) Bidders/Tenderers are to ensure that they are GST compliant and that their quoted tax structure/rates are as per GST law. The rates should be exclusive of taxes and applicable tax percentage should be clearly indicated. Financial/Price Bid format where taxes cannot be mentioned separately, in such cases, the percentage of taxes applicable should be mentioned in the Technical Bid document.
- x) **Validity of Quotation:** Quoted rates must be valid for at least **180 days** from the last date of submission of quotation.
- xi) Applicable levies, surcharge and discounts should be clearly indicated item wise.
- xii) The rates should be quoted along with supporting documents of specifications and technical features and list of users, wherever applicable.
- xiii) **Genuine Pricing:** Vendor is to ensure that quoted price is not more than the price offered to any other customer in India to whom this item has been sold, particularly to Universities/IITs/Institutes and other Government Organization.
- xiv) **Payment:** 100% payment after successful delivery, arrangement of bedrolls and acceptance by the end user department.
- xv) **PENALTY FOR DELAYED DELIVERY:** The date of delivery should be strictly adhered to. In the event of delayed delivery, installation & commissioning, the vendor shall be liable for a penalty deduction/liquidated damages as per prevailing rules.
- xvi) Irresponsive/incomplete quote will be rejected.
- xvii) **Conditional tenders not acceptable:** All the terms and conditions mentioned herein must be strictly adhered to by all the vendors. Conditional tenders shall not be accepted on any ground and shall be rejected straightway. Printed conditions mentioned in the tender bids submitted by vendors will not be binding on Tezpur University.
- xviii) **Enquiry during the course of evaluation not allowed:** No enquiry shall be made by the bidder(s) during the course of evaluation of the tender till final decision is conveyed to the successful bidder(s). However, the Purchase Committee or its authorized representative (Tezpur University) can make any enquiry/seek clarification from the bidders. In such a situation, the agency must extend full co-operation. The bidders may also be asked to arrange demonstration of the offered items, in a short period notice, as such the bidders have to be ready for the same.
- xix) **Termination for default:** Default is said to have occurred:
- If the equipment or any of its component is found having poor workmanship, faulty designs, poor performance and bad quality of materials used.
 - If the supplier fails to deliver any or all of the services within the time period(s) specified in the purchase order or any extension thereof granted by Tezpur University.

- d. Under the above circumstances Tezpur University may terminate the contract / purchase order in whole or in part and forfeit the EMD/PBG as applicable. In addition to above, Tezpur University may at its discretion also take the following actions: Tezpur University may procure, upon such terms and in such manner, as it deems appropriate, goods similar to the undelivered items/products and the defaulting supplier shall be liable to compensate Tezpur University for any extra expenditure involved towards goods and services obtained. Besides, the Vice-Chancellor, Tezpur University, and reserves the right to impose any other form of penalty as deemed fit including blacklisting of the vendor.

B. Selection criteria:

i. Evaluation Criteria:

To ensure that each bidder has the necessary qualifications and resources to fulfill its obligations under the contract, the submitted bids shall be evaluated on the criteria of eligibility, requisite experience & support service framework (if applicable). Upon passing of the bids in the aforesaid criteria, the technical bids shall be evaluated and ranked by the award of ACCEPT and/or REJECT. In case a joint venture makes a bid, any one of the members of the joint venture need to be qualified for each of the criteria mentioned below.

ii. Non Blacklisting Criteria:

- a. The bidder or the OEM should not be blacklisted by Tezpur University or any other Educational /R&D/ PSU/ Govt organizations. A certificate or undertaking to this effect must be submitted in company/firm letterhead; sealed and signed.

iii. Financial bid evaluation

Technical bids will be evaluated and ranked by the award Accepted & Rejected. Only the technically qualified bids shall be considered for financial bid evaluation.

- iv. **Delivery Period** The delivery should be completed by 9:00AM on 30.12.2023 for day 1 and by 9.00AM on 31.12.2023 for day 2.
