Department/Autonomous Body supported by work <u>order and completion certificate</u>. <u>Experience certificate produced as sub-contractor shall not be accepted.</u>

  - (f) GST Registration.
  - (g) Work order(s) & completion certificate(s) to satisfy the Sl. No. 3 of qualifying criteria of this NIT.
