This tender document is required to be uploaded on the website https://eprocure.gov.in along with scanned copies PAN, GST and qualifying documents, as per the qualifying criteria stated above. Incomplete bid documents shall be rejected without giving any reason. There is no need to submit the hard copy of the Tender Document and other documents except Original Declaration regarding correctness of information submitted in this Tender as per NIT in notarized affidavit (As per Annexure V), Tender Fee (non-refundable) and Earnest Money Deposit (refundable)
