Qualifying criteria for interested contractor/bidder:

Contractors/Agencies who fulfill the following requirements shall be eligible to apply.

- 1. Registered with Govt./Semi Govt. Departments/Autonomous Bodies.
- 2. Minimum Annual Turnover during last 3 consecutive financial years shall not be less than **12.12 lakhs** Supported by Balance Sheet and turnover certificate from C.A.
- 3. Should have satisfactorily completed the works as mentioned below, during the last seven years.
- a) One similar works of handling the **WTP** (**Water Treatment Plant**) of same capacity (1MLD) or more, each costing not less than **Rs. 29.38 lakhs** *against single work order* each during last seven years in Govt./ Semi Govt. Department/Autonomous Body supported by **work order and completion certificate**.
- **b)** Two similar works of handling the WTP (**Water Treatment Plant**) of same capacity (1MLD) or more each costing not less than **Rs.18.36 lakhs** against *two separate work orders* each during last seven years in Govt./ Semi Govt. Department/Autonomous Body supported by **two separate work orders and completion certificate**.
- c) Three similar works of handling the **WTP** (**Water Treatment Plant**) of same capacity (1MLD) or more costing not less than **Rs.14.69 lakhs** against *three separate work orders* each during last seven years in Govt./ Semi Govt. Department/Autonomous Body supported by **three separate work order and completion certificate**.
- 4. Bidder shall have at least 10 years experience to undertake single and double treatment plant having minimum capacity of 01 (one) MLD.
- 5. Similar work shall mean "Providing services of Operation and Maintenance of Water Treatment Plant(1MLD) for water purification.
- 6. The tenderer shall sign and stamp each page of this tender document as token of having read, understood and comply with tender, the terms and conditions contained herein. This tender document is required to be uploaded on the website https://eprocure.gov.in along with scanned copies PAN, GST, EPF, ESI, Labour License and qualifying documents, as per the qualifying criteria stated above in serial no.1,2 and 3 and 4. Incomplete bid/documents shall be rejected without giving any reason. There is no need to submit the hard copy of the Tender Document.
- 7. Hard copy of Earnest Money Deposit(refundable), Tender fee (non-refundable) & Affidavit (Notarized) of Declaration regarding correctness of information submitted in this Tender as per NIT which must be submitted in a sealed envelope to be super scribed this Tender name & the name of your agency addressing the Registrar, Tezpur University before the last date and time for receipt of bid. Tender without the EMD and Tender Fee (Non-Refundable) will be summarily rejected.
- 8. Bidder's Technical capability will be determined as per the format given in **Annexure-VI.** Technically disqualified bidder's price bid will not be opened and will not be considered for the next step.
- 9. Downloading of tender paper by a bidder does not automatically mean that the bidder is considered qualified for the work. Tezpur University reserves the right to accept or reject any or all the tender document without assigning any reason thereof.

- 10. The acceptance of tender will rest with the authority of Tezpur University, Napaam, Tezpur who does not bind itself to accept the lowest tender and reserves to itself the right to reject any or all the tenders received without assigning any reason thereof. The work may be allotted in part or whole at the discretion of competent authority of the University.
