Department/Autonomous Body supported by **work order and completion certificate**. **Experience certificate produced as subcontractor shall not be accepted.**

 - (d) Annual turnover certificate from Chartered Accountant.
 - (e) PAN.
 - (f) GST Registration.
 - (g) Work order(s) & completion certificate(s) to satisfy the Sl. No. 3 of qualifying criteria of this NIT.
