Should have completed satisfactorily Interior/ Furniture Works of (i) one work of value not less than 4.50 lakhs against single work order OR (ii) two works of value not less than 2.81 lakhs each against two separate work orders OR (iii) three works of value not less than 2.25 lakhs each against three separate work orders during last seven years in Govt./ Semi Govt. Department/Autonomous Body supported by work order and completion certificate.

 - (d) Annual turnover certificate from Chartered Accountant.
 - (e) PAN.
 - (f) GST Registration.
 - (g) Work order(s) & completion certificate(s) to satisfy the Sl. No. 3 of qualifying criteria of this NIT.
