1.2 QUALIFYING CRITERIA FOR INTERESTED CONTRACTOR / BIDDER

Contractors/Firms who fulfil the following requirements shall be eligible to apply.

1. The bidder must be registered in any Govt./Semi Govt. Departments/Autonomous Bodies who award works to the contractors.
2. Average Annual Turnover along with Audited balance sheet and Income Statement certified by a Chartered Accountant for any 3 consecutive financial years during last 04 years starting from financial year 2022-2023 shall not be less than **33% of the estimated cost put to this tender.**

3. The bidder should have satisfactorily completed the similar works as mentioned below during the last 7 years ending last date of month previous to the one in which tender is invited.
 - 03 (Three) similar completed works costing not less than the amount equal to 40% of the estimated cost put to this tender.
 - Or
 - 02 (Two) similar completed works costing not less than the amount equal to 50% of the estimated cost put to this tender.
 - Or
 - 01 (One) similar completed works costing not less than the amount equal to 80% of the estimated cost put to this tender.
 - (i) Similar work shall mean “Round the clock Operation and Maintenance of electrical substations / 33kV, 11kV overhead and underground line / transformers / HT-LT panels / DG sets / complete electrical installation system / facilities in buildings, township or similar institutional / industrial campus”.
 - (ii) The bidder must submit the copies of **work order and completion certificates** of the completed work / works.
4. The bidder shall sign and stamp each page of this tender document as token of having read, understood and comply with tender, the terms and conditions contained herein. 5. Bidders will be required to upload the scanned copies of the notarized affidavit declaring the correctness of the information furnished in the tender, all other qualifying documents as per the tender, and the tender document duly signed and stamped on every page.

8. Bidders who are MSME / NSIC registered may claim exemption from payment of EMD, subject to submission of valid documents in support of their claim and ANNEXURE – VIII of the tender document.
9. **The contractor shall submit record of visiting the campus with a Geotagged Photograph. The contractor is advised to visit the campus during working days (before the submission of the Tender) to physically inspect and ascertain the types of Electrical installations facilities in TU campus. No claim or variation on account of ignorance or lack of knowledge regarding the types of electrical installations facilities, site conditions, types of building, or quantum of work shall be entertained at a later stage.**
10. **The bidder shall submit a valid Electrical Contractor's License issued by the Competent Authority (Electrical Licensing Board, Government of Assam / Central Electricity Authority) authorizing execution of both HT (High Tension) and LT (Low Tension) electrical works.**
11. **Bidders are required to upload the following documents. Non-submission will lead to disqualification of the bid.**
1. Scanned copy of the complete tender document duly stamped and signed by the bidder as a token of having read and understood the terms and conditions of tender document.

- 12. Bidder's Technical capability will be determined as per the format given in ANNEXURE – IX. Technically disqualified bidder's price bid will not be opened and will not be considered for the next step.**
- 13. Even though the bidders meet the above qualifying criteria, they shall be liable to be disqualified if they have**
- a) Record of poor performance during the last five (05) years as on the date of application such as abandoning the works, rescind of the contract for which the reasons are attributable to the non-performance of the contractor, inordinate delay in completion, consistent history of litigation / arbitration awarded against the applicant or any of its constituents or financial failure due to bankruptcy.
 - b) Shown very poor performance in the implementation of works of Tezpur University.
14. Downloading of tender document by a bidder does not automatically mean that the bidder is considered qualified for the work. Tezpur University reserves the right to accept or reject any or all the Tender document without assigning any reason thereof.
15. The acceptance of tender will rest with the authority of Tezpur University, Napaam, Tezpur who does not bind itself to accept the lowest bidder and reserves to itself the right to reject any or all the bidders received without assigning any reason thereof. The work may be allotted in part or whole at the discretion of competent authority of the University.
